The Investment Option produced a solid positive return over the March quarter, as global bonds gained in value and yields fell on the back of traders leaning towards bonds amid increased volatility in sharemarkets.

Market Review

Australian listed property pulled back in the March quarter. The data centre sector was negatively impacted by the release of DeepSeek's large language model, raising concerns about the potential weaker demand for data centres relating to AI models.

Outlook

Over the long-term, real assets continue to offer a degree of shelter from inflation and provide desirable characteristics such as stable cash flows and potential capital growth.
