Some members may qualify for discounted administration fees, which would effectively increase the returns shown above. This discount is not applicable to Super Cash or Term Deposits and is subject to change.

If your account is a "Transition to Retirement", you will need to review the unit prices, performance reports and crediting rates for SignatureSuper. You can find your account type in MyAMP within the account information section, simply visit amp.com.au/myamp and log in. Transition to Retirement options commenced from July 2017, so long-term performance prior to this is not applicable.
