Terms and Conditions

1. The promoter is AMP Bank Limited ABN 15 081 596 009, AFSL and Australian Credit Licence 234517 of Level 25, 50 Bridge Street, Sydney NSW 2000 ("**Promoter**").

Promotion

2. The AMP Bank GO \$50 Bonus offer runs from 12:01am AEST 14 September 2026 to 11:59pm AEDT on 31 December 2026 ("**Promotional Period**"), unless varied or withdrawn by the Promoter.

Eligibility

3. Eligible Customers will receive a one-off \$50 bonus payment per eligible AMP Bank GO Everyday Account ("**\$50 Bonus**").
4. The \$50 Bonus offer is only available to customers who:
 - a. receive an email communication from the Promoter about the \$50 Bonus offer;
 - b. are not an AMP Bank GO customer at the time they receive the email communication from the Promoter about the \$50 Bonus offer;
 - c. open a new AMP Bank GO Everyday Account by 11:59pm AEDT on 31 December 2026. To learn more about the AMP Bank GO Everyday Account, visit <https://www.amp.com.au/appterm>;
 - d. deposit at least \$1,000 as one or more transactions into the new AMP Bank GO Everyday Account within the first 30 days of account opening;
 - e. maintain their AMP Bank GO Everyday Account in good standing at the time the \$50 Bonus payment is to be credited; and
 - f. comply with these Terms and Conditions. ("**Eligible Customers**")

5. AMP Bank GO Everyday Business Accounts are not eligible for the \$50 Bonus offer.

Payment of \$50 Bonus

6. The \$50 Bonus is paid at an account level. For example, if an eligible AMP Bank GO Everyday Account is held jointly, only one \$50 Bonus payment will be made to that account, regardless of the number of account holders.
7. The \$50 Bonus will be credited to the linked everyday personal transaction account issued by the Promoter and accessible through AMP Bank GO (**"AMP Bank GO Everyday Account"**).
8. The \$50 Bonus is not transferable or exchangeable and cannot be taken as cash. It will be paid in accordance with these Terms and Conditions.
9. The \$50 Bonus payment is paid in Australian dollars.
10. The \$50 Bonus will generally be credited to the eligible AMP Bank GO Everyday Account in the calendar month after the customer has met the qualifying deposit requirements by the relevant month end. For example, if a customer meets the eligibility criteria for the \$50 Bonus in October, the customer will be credited the \$50 Bonus payment to their AMP Bank GO Everyday Account in November. The \$50 bonus payment may appear as "AMP Bank GO Bonus" (or similar) in your AMP Bank GO Everyday Account transaction listing.
11. The Promoter reserves the right to disqualify any customer who it reasonably believes has breached these Terms and Conditions, acted fraudulently, misleadingly, or unlawfully, manipulated the eligibility process, or otherwise acted contrary to the spirit, intent or fair operation of the Promotion.
12. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may cancel, terminate,

modify or suspend the Promotion subject to State or Territory regulation.

13. The Promoter is not responsible for delays caused by third-party merchants, payments providers, payment networks or system issues.

Frequently Asked Questions

1. What is the AMP Bank GO \$50 Bonus offer?

The AMP Bank GO \$50 Bonus offer gives Eligible Customers a one-off \$50 bonus when they open a new AMP Bank GO Everyday Account by 31 December 2026 and deposit at least \$1,000 into that account within the first 30 days of account opening.

2. Who is eligible for the \$50 Bonus offer?

You may be an Eligible Customer if you:

- receive an email from AMP Bank about this \$50 Bonus offer;
- are not already an AMP Bank GO customer at the time you receive the campaign email;
- open a new AMP Bank GO Everyday Account by 31 December 2026;
- deposit at least \$1,000 into the new AMP Bank GO Everyday Account within the first 30 days of account opening; and
- maintain your AMP Bank GO Everyday Account in good standing at the time the \$50 Bonus is credited.

3. Do I need to receive the campaign email to be eligible?

Yes. This offer is only available to customers who receive an email communication from AMP Bank about the \$50 Bonus offer.

If you did not receive the campaign email, or you were already an AMP Bank GO customer when you received the campaign email, you will not be eligible for the \$50 Bonus offer, even if you open another AMP Bank GO Everyday Account and meet the deposit requirement. 4. What do I need to do to qualify?

To qualify, you must open a new AMP Bank GO Everyday Account by 31 December 2026 and deposit at least \$1,000 into that account within the first 30 days of account opening.

5. How much is the bonus payment?

Eligible Customers will receive one \$50 Bonus payment per eligible AMP Bank GO Everyday Account. The \$50 Bonus is paid at an account level, so a joint account will receive one \$50 Bonus payment only.

6. When will I receive my \$50 Bonus payment?

Where you have met the qualifying deposit requirement by the relevant month end, the \$50 Bonus will generally be credited to your eligible AMP Bank GO Everyday Account by the following calendar month within the first 10 business days. For example, if a customer meets the eligibility criteria for the \$50 Bonus in October, the customer will be credited the \$50 Bonus payment to their AMP Bank GO Everyday Account in November.

7. What happens if I close my account before the \$50 Bonus is paid?

Your AMP Bank GO Everyday Account must remain open and in good standing when the \$50 Bonus is credited. If your account is closed, restricted, suspended, blocked, cancelled or otherwise not in good standing when the bonus is due to be paid, the \$50 Bonus will be forfeited.

8. Can I withdraw or spend any of the \$1,000 after I deposit it?

Yes, you may withdraw, transfer or spend money from your AMP Bank GO Everyday Account after making a deposit, as long as you deposit at least \$1,000 into your AMP Bank GO Everyday Account within the first 30 days of account opening. The \$1,000 deposit requirement can be met through one or more deposits during that 30-day period.
