

# TERMS & CONDITIONS - TAP. PAY. WIN.

## 1. Promoter

The promoter is AMP Bank Limited, ABN 15 081 596 009, AFSL and Australian credit licence 234517 of Level 29, 50 Bridge Street, SYDNEY New South Wales 2000 ("AMP Bank").

## 2. Promotion Period

The promotion commences at 12:00am AEST on 11 August 2025 and ends at 11:59pm AEST on 28 September 2025 ("Promotion Period").

# 3. Eligibility

- Reside in any Australian state or territory (except for South Australia)

- Hold an open AMP Bank GO Everyday Transaction or Everyday Business Transaction account when any prize is to be deposited.
