We'd like to let you know about some changes to the below investment products (the Funds):

- AMP Capital Equity Income Generator (registered name AMP Capital Australian Equity Income Fund) Class H (Personal investors)
- AMP Capital Multi-Asset Fund Class H (Personal investors)

As we simplify our business, we're reducing the number of investment products we offer.

Accordingly, we've decided to close the above unit classes of the two Funds to new investment.

What this means for you

The Funds will be closed to any further investment from 10 May 2022.

As a current investor, you can choose to:

- Stay invested
- Withdraw some of your investment; or
- · Withdraw all of your investment.

The following arrangements will end on 10 May 2022:

Any reinvestment of distribution payments – these will instead be credited to your nominated bank account.
Where we don't have your bank account details on file, a cheque will be issued and mailed to you.

What you need to do

You may want to speak with your financial adviser about any changes you'd like to make. Otherwise:

- If you're happy with your current investment (noting that you can't make any additional investments into that particular Fund), you don't need to do anything, and we will continue to manage your investment in the same manner.
- If you decide to withdraw your investment, we'll make a payment to your nominated bank account. Where we don't have your bank account details on file, a cheque will be issued and mailed to you.
