Investment Option Commentary

The Fund gained from long positions in Equity Indices, which were lifted by buoyant stock markets. Global equities rose to an all-time high during December, to deliver their best calendar-year performance since 2009. Information Technology stocks and the commodity-related Energy and Materials sectors led equity market gains over the month, while emerging market indices outperformed their developed market counterparts.

Market Commentary

Profits were reduced by losses from long positions in Fixed Income, with fixed income markets falling for the fourth consecutive month as yields on government bonds continued to rise, as well as short exposure to crops such as coffee and wheat. Short exposure to the euro led to negative performance in Currencies.
