Aim and Strategy

To provide returns (after fees and before tax) which exceed inflation over the longer term, but with lower returns and less variability of returns than would be expected from an investment option with the same exposure to bonds, cash, shares and property.

The investment strategy is to invest in a diversified portfolio with a core of cash and bonds and limited exposure to shares and property. Changes to investments can be made according to the outlook for the various investment sectors and the nature of the plan. This is a crediting rate investment option.

Investment Option & Market Commentary

Aggregate returns on the underlying investment portfolios were positive over the quarter, driven primarily by increases in the values of listed domestic and global equity assets. Medium to long term bond yields in Australia reduced from their year-end peak levels (by around 70bps) and while this generates some positive capital returns from fixed interest holdings, it lowers our outlook for future return expectations.

The table below sets out the net crediting rates (after tax and before fees) that applied at the start of the last five quarters.
