



## SignatureSuper investment performance summary for the Coca-Cola Amatil Superannuation Plan

The table below shows the value of the Large Plan Discount and Total Returns for the Coca-Cola Amatil Superannuation plan.

Members may qualify for a Large Plan Discount of up to 0.86% pa which has a value of 0.73% pa after allowance for earnings tax. This discount is applicable to Choice investment options only, except for funds invested in AMP Super Cash and AMP Term Deposits which have a Large Plan discount of up to 0.70% pa with a value of 0.60% pa after allowance for earnings tax. These discounts are subject to change and are not applicable to the MySuper investment option. MySuper pricing has a lower administration fee than choice investment options and so the discount is already factored into the fees and costs of the CCA MySuper Future Directions investment options.

Total Returns are investment returns net of Administration Fees, Investment Management Fees, performance based fees (where applicable) and investment earnings taxes. It assumes a sum of money is invested at the beginning of the time period and neither drawn upon nor added to throughout that period.
