## Voting Rights Exercised During the 2017/2018 Financial Year

During the 2017/2018 financial year, N.M. Superannuation Proprietary Limited (“NM Super”) was Trustee of the following platform registrable superannuation entities (“RSEs”):

- Wealth Personal Superannuation and Pension Fund ABN 92 381 911 598; and
- The Retirement Plan ABN 40 236 806 679.

The assets of the RSEs above were invested through the platform operator NMMT Limited (“NMMT”) during the period. Both NM Super and NMMT are members of the AMP Group. NMMT provided investment and administration services to NM Super in relation to the RSEs.

In accordance with the AMP Proxy Voting Policy, NMMT exercises voting rights on behalf of NM Super in respect of resolutions for managed investment schemes and shares in listed companies where these investments are held directly on behalf of RSE members.

During the 2017/2018 financial year, NMMT voted on behalf of NM Super where the resolution was assessed to have a material impact on the value of the underlying investments.

The records below show the proxy votes undertaken by NMMT on behalf of NM Super between 1 July 2017 and 30 June 2018 in relation to investments of the RSEs.
